

**2020 HEARTHSTONE® MASTERS TOUR – PLAYER PARTICIPATION AGREEMENT AND ACCEPTANCE FORM**

**Instructions:** The Hearthstone Masters Tour Official Competition Rules and Hearthstone Tournament Player Handbook, including any updates or amendments to both documents (together, the “**Official Rules**”), and the following terms and conditions, govern the terms of participation in Blizzard Entertainment, Inc. and its affiliates’ (“**Blizzard**”) 2020 Hearthstone Masters Tour Arlington esports competition, which is taking place in Arlington, Texas (USA) on January 31 – February 2, 2020 (the “**Competition**”). You must accept the Official Rules in order to participate as a player in the Competition. You can accept the Official Rules by checking the “Accept” boxes below and by signing this Player Participation Agreement and Acceptance Form (“**Agreement**”). If you check “Decline” on any of the boxes below, or if you don’t check either “Accept” or “Decline,” then you will not be permitted to participate in the Competition. If you are under the age of a legal adult in your country of residence, and your parent or guardian does not agree to the terms at the bottom of this Agreement by signing below, and you have not obtained the signature of a witness to your parent or guardian’s signature at the bottom of this Agreement, you will not be permitted to participate in the Competition.

<b>License to Record and Use Your Name and Likeness:</b>	
I hereby grant to Blizzard the royalty-free, fully paid-up, worldwide, nonexclusive right and license (with the right to grant sublicenses) to copy, display, distribute, edit, transmit, host, store and otherwise use my name, nickname, tag, logo, initials, likeness, image, photograph, video recordings, animation, autograph, voice, public persona, biographical information and backstory, and create derivative works thereof, in any and all present and future media, on or in connection with (a) any group licensing or other agreements entered into by Blizzard related to <i>Hearthstone</i> or Blizzard’s <i>Hearthstone</i> esports competitions, (b) the broadcast, streaming, webcast or other distribution of any audio visual, visual and/or audio coverage of Blizzard’s <i>Hearthstone</i> esports competitions or other related events (whether in full or in part and whether on a live or delayed basis); (c) activities related to the advertising, marketing and promotion of Blizzard’s <i>Hearthstone</i> esports competitions, Blizzard, or <i>Hearthstone</i> ; and/or (d) the distribution, advertising, promotion and sale of the products and services of Blizzard.

<b>Limitations of Liability:</b>	
I agree that the liability of Blizzard, and their respective affiliate companies to me for all harm, damages, injury or loss shall be limited to my direct damages not to exceed US \$500.00, and this shall be my only remedy regardless of what legal theory is used to determine that Blizzard, or any of their respective affiliate companies was liable for the harm, damages, injury or loss. <b>Other Terms and Conditions:</b>	
This Agreement shall be governed by the laws of the State of Delaware, USA, without regard to choice of law principles. This Agreement shall be effective and binding upon your heirs, next of kin, executors, administrators, assigns and representatives. Any dispute with or claim against Blizzard, or any of its respective affiliate companies arising out of or based on this Agreement or your participation in Blizzard’s <i>Hearthstone</i> esports competitions shall be governed by Section 8 of the <i>Hearthstone</i> Tournament Player Handbook. If any provision of this Agreement is so broad as to be unenforceable, such provision shall be interpreted to be only so broad as is enforceable. In entering into this Agreement, you are not relying on any oral or written statements or representations made by any person with respect to its contents or subjectmatter. This Agreement is in addition to, and not in lieu of, the Official Rules and may not be amended except by a written amendment signed by Blizzard. In the event of a conflict between the Official Rules and this Agreement, the Official Rules shall govern and control. This Agreement, including the Official Rules, constitutes the entire agreement between the parties with respect to its subject matter and supersedes any prior oral or written agreements related thereto.
