

## Official Rules

### World of Warcraft® Hellfest 2017 Contest

**1. Eligibility.** BLIZZARD ENTERTAINMENT SAS, A FRENCH COMPANY (referred to herein as “Sponsor”) IS THE SPONSOR OF THIS CONTEST (the “Contest”). THIS CONTEST IS OPEN TO ANYONE AGED 18 OR MORE RESIDING IN EUROPEAN UNION (the “Entrants”). **If you are between the age of thirteen (13) years of age and the legal age of majority in your country of residence, one of your parents or legal guardians must submit a signed, written statement that they have read, understood and agree to these Contest rules with your entry, and that such agreement constitutes acceptance of these Contest rules on behalf of you and themselves.** To be eligible to win a prize, entries must be completed and received by Sponsor in the format designated below. Directors, officers and employees of Sponsor, its parent, and any of their respective affiliate companies, subsidiaries, agents, professional advisors, advertising and promotional agencies, and immediate families of each are not eligible to win any prizes. **3. Contest Period.** The Contest shall commence on 18:00 CEST June 13, 2017 (the “Start Date”), and shall continue in duration until 23:59 CEST June 20, 2017 (the “Deadline”). All entries must be received by the Deadline and in accordance with these official rules to be eligible to win a prize.

#### **4. How to Enter.**

Determination of winners.** On or before June 30, 2017 Sponsor shall randomly select twenty-one (21) qualified (the “Winners”) among qualified Entrants who meet the requirements defined in Section 4 of these Official Rules. The Winners will be eligible to obtain a prize defined in Section 6 of these Official Rules. The Winners will be contacted by email before July 15, 2017 to obtain the Winners’ mailing addresses (which shall be sent by the Winner to Sponsor on or before July 31, 2017) for prize distribution. The prizes shall be sent by mail before August 31, 2017.

- ix. The twentieth and twenty-first Winners will each receive one (1) Funko Pop! Vinyl Sylvanas (approximate retail value of €9.00).

All Contest Winners will be notified via email provided in the Contest Tool.

**7. Collection of Information.** The information submitted to Sponsor during the registration for the Contest via web-site "gleam.io" operated by "Crowd9 PTY Ltd" (the "Operator") will be used to contact you in the event that you are chosen to receive the prize and as otherwise specified in Sponsor's Privacy Policy, available at <http://eu.blizzard.com/en-gb/company/about/privacy.html>. Note that the data collector for this Contest are Blizzard Entertainment SAS, and Crowd9 PTY Ltd, and the data collected will be transferred to the United States of America and Australia. The details of each Entrant (name, email address) will be transmitted by the Sponsor's and Operator's server, which will process the data. The data will be collected during the Contest of each Entrant according to the «Informatique et Libertés» law, of the 6th of January 1978 and its later amendments, and according to the European directive number 95/46/CE. Each Entrant grants Sponsor permission to use the information he is providing within the framework set by the «Informatique et Libertés» law of the 6th of January 1978.
