Overwatch® Halloween 2017 Budget Cosplay Contest ("Official Rules")

- 1. Eligibility. BLIZZARD ENTERTAINMENT SAS, A FRENCH COMPANY with its address at 145 rue Yves le Coz, 78000 Versailles, France (referred to herein as the "Sponsor"), IS THE SPONSOR OF THIS CONTEST (the "Contest"). - (ii) tweet a predetermined text from his/her own Twitter account by clicking on the respective button on the Social Media Platform.

An approximate retail value of the bundle €135,00). Five (5) bundles of that sort will be distributed in total for the Contest.;
- **7. Sponsor Use of Entry Materials.** Entrant hereby agrees that upon posting the Entry Materials for the Contest, Entrant hereby grants Blizzard Entertainment SAS and its subsidiaries and affiliates a perpetual, non-exclusive, worldwide license and right to utilize the Entry Materials.
