

Overwatch® Winter Wonderland sweepstake (“Official Rules”)

1. Eligibility. BLIZZARD ENTERTAINMENT SAS, A FRENCH COMPANY with its address at 145 rue Yves le Coz, 78000 Versailles, France (referred to herein as the “Sponsor”), IS THE SPONSOR OF THIS SWEEPSTAKE (the “Contest”). This Contest is open to anyone aged thirteen (13) or over residing in AUSTRIA, BELGIUM, BULGARIA, CROATIA, CZECH REPUBLIC, DENMARK, ESTONIA, FINLAND, FRANCE, GERMANY, GREECE, HUNGARY, ICELAND, IRELAND, ITALY, LATVIA, LITHUANIA, LUXEMBOURG, MALTA, NETHERLANDS, NORWAY, POLAND, PORTUGAL, ROMANIA, SLOVAKIA, SLOVENIA, SPAIN, SWEDEN, SWITZERLAND, THE UNITED KINGDOM (the “Entrant”). **If you are between the ages of thirteen and the legal age of majority in your country of residence (a "Minor"), one of your parents or legal guardians must submit a signed, written statement that they have read, understood, and agree to these Contest rules with your entry, and that such agreement constitutes acceptance of these Contest rules on behalf of you and themselves.** Directors, officers, and employees of Sponsor, its parent company, and any of their respective affiliate companies, subsidiaries, agents, professional advisors, advertising and promotional agencies, and immediate families of each are not eligible to win any prizes. 3. Contest Period. The Contest shall commence on Tuesday, December 14, 2018 at 10:00 CET, and shall end on Monday, December 31, 2018 at 23:59 CET.

4. How to Enter the Contest.

4.1. To enter the Contest, an Entrant must:

Each of the abovementioned actions increases the chance to win by five.

Note that the data controller for the processing of your personal data for this Contest is Blizzard Entertainment SAS. The details of each entrant (email address and name) will be transmitted by the Sponsor's and Operator's servers, which will process the data.
