

## 2017 TESPA GRAND ADVENTURE CONTEST

- 1. Eligibility.** TESPA, INC., A DELAWARE CORPORATION, (“TESPA”) IS THE SPONSOR OF THE 2017 TESPA GRAND ADVENTURE CONTEST (“CONTEST”). ELIGIBILITY FOR THIS CONTEST IS LIMITED TO RESIDENTS OF THE UNITED STATES AND CANADA WHICH ARE: (i) OVER THE AGE OF MAJORITY IN THEIR COUNTRY OF RESIDENCE, or if they are under the legal age of majority in THEIR country of residence on January 17, 2017, are able to submit a signed, written statement that a parent or guardian has read, understood and agrees to these Contest rules with their entry, and that such agreement constitutes acceptance of these Contest rules on behalf of the parent or guardian and themselves, and they are over 13 years of age and a resident of the United States of America or Canada, AND (ii) WHO ARE NOT RESIDENTS OF THE STATES OF NORTH DAKOTA, VERMONT, CONNECTICUT, OR MARYLAND IN THE UNITED STATES, OR THE PROVINCE OF QUEBEC IN CANADA (“ENTRANTS”). IF YOU ARE NOT A RESIDENT OF THESE AREAS AND/OR OTHERWISE DO NOT MEET THE ABOVE ELIGIBILITY REQUIREMENTS, YOU ARE NOT ELIGIBLE TO WIN A PRIZE. To be eligible to win a prize, entries must be completed and received by Sponsor in the format designated below. Directors, officers and employees of Sponsor, its parent, and any of their respective affiliate companies, subsidiaries, agents, professional advisors, advertising and promotional agencies, and immediate families of each are not eligible to win any prizes. All applicable federal, state and local laws and regulations apply. There is no cost to enter or win. Offer void where prohibited. In the event of any dispute, entries will be deemed to have been submitted by the owner of the Twitter account from which the tweet was sent.
- 2. Disclaimer.** Sponsor, all participating sponsors and any of their respective parent companies, subsidiaries, affiliates, directors, officers, professional advisors, employees and agencies will not be responsible for: (a) any late, lost, misrouted, garbled or distorted or damaged transmissions or entries; (b) telephone, electronic, hardware, software, network, Internet, or other computer- or communications-related malfunctions or failures; (c) any Contest disruptions, injuries, losses or damages caused by events beyond the control of Sponsor; or (d) any printing or typographical errors in any materials associated with the Contest.
- 3. Contest Period.** The Contest shall commence on 12:01 p.m., Pacific Daylight Time (PDT) on January 17, 2017 (the “Start Date”), and shall continue in duration until 11:59 PM PDT on March 20, 2017 (the “Deadline”). All entries must be received by the Deadline to be eligible to win a prize.
- 4. Prize.** One (1) qualified Entrant will be chosen by Sponsor as the winner of the Contest (the “Winner”), and will receive a prize package consisting of the following: (i) One (1) tour of Twitch.tv’s San Francisco, California headquarters on a date between April 1, 2017 and August 31, 2017 for the Winner and the “Period 3” Tespa chapter event support applicant belonging to the Winner’s Tespa chapter (the “Support Applicant”), with an approximate retail value of \$0.00; (ii) Round trip airfare for the Winner and the Winner’s Support Applicant between an airport near the Winner’s origin city and San Francisco or Oakland, California during a date range between April 1, 2017 and August 31, 2017, with an approximate retail value of \$1,600.00; (iii) Hotel accommodations for the Winner and the Winner’s Support Applicant on two (2) consecutive weeknights in San Francisco, California during a date range between April

1, 2017 and August 31, 2017, with an approximate retail value of \$1,600.00; (iv) One (1) check or pre-paid VISA card in the amount of \$150.00 for the Winner; and (v) One (1) check or pre-paid VISA card in the amount of \$150.00 for the Winner's Support Applicant. ALL FEDERAL, STATE AND LOCAL TAXES ASSOCIATED WITH THE RECEIPT OR USE OF ANY PRIZES ARE THE SOLE RESPONSIBILITY OF THE WINNER. All prizes will be awarded. The Winner must execute an affidavit of eligibility before they can receive their Prize. If the Prize is not claimed within five (5) days after delivery of notification, the Prize will be forfeited and awarded to an alternate Winner. The Winner must select all dates for their Prize tour, flights, and hotel accommodations within seven (7) days of claiming the Prize. In the event that the Winner is also the "Period 3" Tespa chapter event support applicant associated with the Winner's Tespa chapter, the Winner may select a Tespa chapter officer belonging to the Winner's Tespa chapter as a substitute for the portion of the Prize intended for the Winner's Support Applicant. No other substitutions or exchanges (including for cash) of any prize will be permitted, except that Sponsor reserves the right to substitute a prize of equal or greater value for any prize. Limit one prize per household or address. All prizes are awarded "AS IS" and WITHOUT WARRANTY OF ANY KIND, express or implied, (including, without limitation, any implied warranty of merchantability or fitness for a particular purpose).

- 5. How to Enter.** To enter, a qualified Entrant must: (i) have registered for a MyTespa member account on <http://Tespa.org> and maintain a Tespa membership in good standing; (ii) have registered for a Twitter account on <http://Twitter.com>; (iii) be a "follower" of the "@TeamTespa" Twitter account via Entrant's Twitter account; and (iv) publish a public Tweet via Entrant's Twitter account containing "@TeamTespa", the hashtag "#TheGrandAdventure", and a wholly original photograph of a Tespa-affiliated gathering that captures the theme of a "Grand Adventure," which may include creative or funny uses of the items contained in "The Grand Adventure" event support packages distributed by Sponsor to certain Tespa chapters. A submission must contain your original photograph, and cannot include, in whole or part, any previously created work (i.e. a photoshop manipulation of an existing image would be disqualified). Entrant must have permission from all identifiable people contained within a submission to submit their image and likeness as part of the Contest.
- 6. Contest Rules.** Sponsor shall choose the winners from all Entrants who have submitted an entry prior to the Deadline. Winners shall be chosen by Sponsor at its sole discretion based upon which Entrants display the most original and/or funny photograph that best captures the theme of a "Grand Adventure." The decision of Sponsor is final. Prize winners will be notified via <http://Twitter.com> "direct message" within seven (7) days thereafter. To claim a prize, winners should follow the instructions contained in their notification.
- 7. Sponsor Use of Entries/Publicity Release.** You hereby agree that in consideration of your being allowed the chance to enter the Contest, you hereby grant Sponsor a perpetual, non-exclusive, worldwide license and right to utilize the entry materials that you submit to Sponsor, along with your name, character, likeness, statements about the Contest, and biographical information in connection with the Contest (collectively, "Entry Materials"). The Entry Materials will not be returned to any entrant. Without limiting the generality of the foregoing, you acknowledge that Sponsor shall have the right to use, modify, reproduce, publish, perform,

display, distribute, make derivative works of and otherwise commercially and noncommercially exploit the Entry Materials in perpetuity and throughout the universe, in any manner or medium now existing or hereafter developed, without separate compensation to you or any other person or entity. You agree to take, at Sponsor's expense, any further action (including, without limitation, execution of affidavits and other documents) reasonably requested by Sponsor to effect, perfect or confirm Sponsor's rights as set forth above in this paragraph 7.

- 8. Original Work of Authorship.** You hereby warrant and represent that (a) you own all rights to all Entry Materials submitted by you; and (b) all such Entry Materials are original works of authorship on your part and have not been copied, in whole or in part, from any other work and do not violate, misappropriate or infringe any copyright, trademark or other proprietary right of any other person or entity.
- 9. Collection of Information.** By entering the Contest, you consent to Sponsor's use of any identifying information that you submitted with the Entry Materials to inform you of open positions with Tespa, and to associate your name with your submission in promotional materials for the Contest in the event that you are chosen to be a winner. As stated above, the contest is not open to anyone under the age of majority in your country of citizenship. In the event that Sponsor becomes aware that you are under the age of majority in your country of citizenship, Sponsor will delete, erase or destroy any and all personally identifiable information that is obtained from the Entry Materials.
- 10. General Release.** By entering the Contest, you release Sponsor, participating sponsors and any of their respective parent companies, subsidiaries, affiliates, directors, officers, employees and agencies (collectively, the "Released Parties") from any liability whatsoever, and waive any and all causes of action, related to any claims, costs, injuries, losses, or damages of any kind arising out of or in connection with the Contest or delivery, misdelivery, acceptance, possession, use of or inability to use any prize (including, without limitation, claims, costs, injuries, losses and damages related to personal injuries, death, damage to or destruction of property, rights of publicity or privacy, defamation or portrayal in a false light, whether intentional or unintentional), whether under a theory of contract, tort (including negligence), warranty or other theory.
- 11. Affidavit & Release.** As a condition of being awarded any prize, winners will be required to execute and deliver to Sponsor a signed Affidavit of Eligibility, which includes an acceptance of these Official Rules and a release of liability.

Sponsor reserves the right to change these Official Rules at any time, in its sole discretion, and to suspend or cancel the Contest or any entrant's participation in the Contest should viruses, bugs, unauthorized human intervention or other causes beyond Sponsor's control affect the administration, security or proper operation of the Contest or Sponsor otherwise becomes (as determined in its sole discretion) incapable of running the Contest as planned. Entrants who violate these Official Rules, tamper with the operation of the Contest or engage in any conduct that is detrimental or unfair to Sponsor, the Contest, or any other entrant (in each case as determined in Sponsor's sole discretion) are subject to disqualification from entry into the Contest. Sponsor reserves the right to lock out persons whose eligibility is in question or who have been disqualified or are otherwise ineligible to enter the Contest.
