STARCRAFT®: REMASTERED LAN PARTY PIZZA CONTEST

OFFICIAL RULES

- 1. Eligibility. BLIZZARD ENTERTAINMENT, INC., A CORPORATION, DELAWARE ("BLIZZARD") IS THE SPONSOR OF THE STARCRAFT®: REMASTERED LAN PARTY PIZZA CONTEST ("CONTEST"). - **3. Contest Period.** The Contest shall commence at 3:00 P.M., Pacific Daylight Time ("PDT") on August 14, 2017 (the "Start Time"), and shall continue in duration until 9:00 P.M. PDT on August 14, 2017 (the "Deadline"). All entries must be received by the Deadline to be eligible to win a Prize (as defined below).
- **4. How to Enter.** Qualified Entrants may enter the Contest by: (i) registering or have registered for either a Twitter account on http://twitter.com; and (ii) publishing a public Tweet via Entrant's Twitter account that contains the hashtag "#StarCraftPizzaMe" and a wholly original photograph of Entrant participating in a StarCraft: Remastered LAN party with at least one (1) friend. A submission must contain your original photograph, and cannot include, in whole or part, any previously created work (i.e. a photoshop manipulation of an existing image would be disqualified). Entrant must have permission from all identifiable people contained within a submission to submit their image and likeness as part of the Contest.

- **5. Contest Rules.** Blizzard shall choose the winners of the Contest (each, a "Winner") from all qualified Entrants who have submitted an entry between the Start Time and Deadline. All decisions of Blizzard are final. To claim a Prize, Winners should follow the instructions contained in their notification. Winners will be chosen by Blizzard at its sole discretion based upon which Entrants display the most creative, humorous, or original photograph of a *StarCraft: Remastered* LAN party. Winners will each receive a prize consisting of five (5) pizzas delivered to an address to be provided by such Winners, with an approximate retail value of Seventy-Five Dollars (\$75.00 USD) (the "Prize").
