## **OFFICIAL RULES**

## HEARTHSTONE® DUELS EARLY ACCESS TWITCH DROPS

Please read these rules ("Official Rules") before participating in the Hearthstone® Duels Early Access Twitch Drops promotion (the "Promotion"). By participating in the Promotion, you agree to be bound by these Official Rules and represent that you satisfy all of the eligibility requirements contained in Section 1 below.

- 1. Eligibility. NO PURCHASE NECESSARY TO ENTER OR WIN. BLIZZARD ENTERTAINMENT, INC. ("SPONSOR") IS THE SPONSOR OF THIS PROMOTION. THIS PROMOTION IS OPEN ONLY TO INDIVIDUALS WHO, AS OF THE DATE OF ENTRY ARE: (A) LEGAL RESIDENTS OF THE UNITED STATES, ARGENTINA, AUSTRIA, BELARUS, BELGIUM, BRAZIL, BULGARIA, CHILE, CROATIA, CZECH REPUBLIC, DENMARK, EGYPT, ESTONIA, FINLAND, FRANCE, GERMANY, GREECE, HONG KONG, HUNGARY, ICELAND, IRELAND, ISRAEL, ITALY, JAPAN, KAZAKHSTAN, LATVIA, LITHUANIA, LUXEMBOURG, MACAU, MALTA, MEXICO, THE NETHERLANDS, NORWAY, PEOPLE'S REPUBLIC OF CHINA, PHILIPPINES, POLAND, PORTUGAL, QATAR, ROMANIA, RUSSIA, SAUDI ARABIA, SERBIA, SINGAPORE, SLOVAKIA, SLOVENIA, SOUTH AFRICA, SOUTH KOREA, SPAIN, SWEDEN, SWITZERLAND, TAIWAN, THAILAND, TUNISIA, TURKEY, UKRAINE, THE UNITED KINGDOM, AND VIETNAM; (B) THIRTEEN YEARS OF AGE OR OLDER AS OF THE DATE OF ENTRY; (C) HAVE AUTHORIZED ACCESS TO A FULL BATTLE.NET ACCOUNT REGISTERED ON BLIZZARD'S BATTLE.NET SERVICE THAT IS IN GOOD STANDING AND WHICH REMAINS IN GOOD STANDING THROUGHOUT THIS PROMOTION; (D) HAVE AUTHORIZED ACCESS TO A TWITCH ACCOUNT THAT IS IN GOOD STANDING AND WHICH REMAINS IN GOOD STANDING THROUGHOUT THIS PROMOTION, AND (E) NOT RESIDENTS OF A JURISDICTION WHERE THIS PROMOTION IS PROHIBITED OR OTHERWISE RESTRICTED BY LAW ("ENTRANTS"). - **3. Promotion Period.** The Promotion will occur between 10:00 AM PT on October 28, 2020 and 11:00 PM PT on November 11, 2020 (the "Promotion Period").
- **4. How to Enter.** Entrants must do the following to participate in the Promotion:
  - (a) Create or log in to your free Blizzard Battle.net account by visiting <a href="https://www.blizzard.com">https://www.blizzard.com</a>;
  - (b) Create or log in to your free Twitch account by visiting <a href="https://www.twitch.tv">https://www.twitch.tv</a>;
  - (c) Connect or have connected your Twitch account to your Battle.net account using your "Connections" account settings on <a href="http://www.twitch.tv">http://www.twitch.tv</a>; and
  - (d) View a Twitch channel which is listed under the *Hearthstone* category and has Twitch drops enabled by the channel owner ("Eligible Channel(s)") during the Promotional Period while logged into your Twitch account.
- **5. Prize Rewards.** All eligible Entrants who satisfy the eligibility requirements for a particular hour during the Promotional Period will be entered into a random draw for the chance to receive access to the *Hearthstone: Duels* game mode for a limited time ("Early Access"). Five hundred (500) Entrants will be chosen at random to receive Early Access during each hour of the Promotional Period. Limit one prize per Entrant. Early Access has a retail value of \$0.00 USD. Early Access will be automatically added to the Blizzard Battle.net accounts of the recipients within forty-eight (48) hours of determination. Early Access is only playable between approximately October 28 November 16, 2020 PT. An internet connection and valid *Hearthstone* game license in good standing is required to utilize the prize. A *Hearthstone* game license is free of charge and can be obtained at <a href="https://playhearthstone.com">https://playhearthstone.com</a>. Noncompliance with these Official Rules may result in disqualification and forfeiture of all prizes.
- **6. Odds of Winning / Prize Award Terms**. The odds of winning a prize depend on the total number of Entrants who submit entries for the Promotion each hour during the Promotional Period. The Entry Materials will not be returned to any Entrant. Without limiting the generality of the foregoing, Entrant acknowledge that Sponsor shall have the right to use, modify, reproduce, publish, perform, display on all forms of media, distribute, make derivative works of and otherwise commercially and non-commercially exploit the Entry Materials in perpetuity and throughout the universe, in any manner or medium now existing or hereafter developed, without separate compensation to you or any other person or entity. Entrant further agrees to take, at Sponsor's expense, any further action (including, without limitation, execution of affidavits and other documents) reasonably requested by Sponsor to effect, perfect or confirm Sponsor's rights as set forth above in this paragraph.
