BLIZZCON 2019 ORIGINAL ART CONTEST RULES

- 1. Eligibility. BLIZZARD ENTERTAINMENT, INC., A DELAWARE CORPORATION, ("BLIZZARD") IS THE SPONSOR OF THE 2019 BLIZZCON ORIGINAL ART CONTEST ("CONTEST"). ELIGIBILITY FOR THIS CONTEST IS LIMITED TO RESIDENTS OF ARE RESIDENTS OF THE UNITED STATES, ARGENTINA, AUSTRIA, BELARUS, BELGIUM, BELIZE, BOLIVIA, BULGARIA, CHILE, CANADA, CROATIA, DENMARK, ECUADOR, EGYPT, EL SALVADOR, ESTONIA, FRANCE, FINLAND, GERMANY, GREECE, GUATEMALA, HONDURAS, HONG KONG, HUNGARY, ICELAND, IRELAND, ISRAEL, ITALY, JAMAICA, JAPAN, KAZAKHSTAN, LATVIA, LITHUANIA, LUXEMBOURG, MACAU, MEXICO, NICARAUGA, NORWAY, PERU, POLAND, PORTUGAL, PUERTO RICO, ROMANIA, RUSSIA, SERBIA, SLOVAKIA, SLOVENIA, SOUTH AFRICA, SOUTH KOREA, SPAIN, STATE OF QATAR, SWEDEN, SWITZERLAND, TAIWAN, THE CZECH REPUBLIC, THE NETHERLANDS, THE PEOPLE'S REPUBLIC OF CHINA, THE UKRAINE, THE UNITED KINGDOM, TRINIDAD AND TOBAGO, TUNISIA, TURKEY, URUGUAY AND VENEZUELA WHICH ARE: (I) OVER THE AGE OF MAJORITY IN THEIR COUNTRY OF RESIDENCE, OR IF THEY ARE UNDER THE LEGAL AGE OF MAJORITY IN THEIR COUNTRY OF RESIDENCE ON JULY 25, 2019, ARE ABLE TO SUBMIT A SIGNED, WRITTEN STATEMENT THAT A PARENT OR GUARDIAN HAS READ. IF YOU ARE NOT A RESIDENT OF THESE AREAS AND/OR OTHERWISE DO NOT MEET THE ABOVE ELIGIBILTY REQUIREMENTS, YOU ARE NOT ELIGIBLE TO WIN A PRIZE. To be eligible to win a prize, entries must be completed and received by Sponsor in the format designated below. Limit one entry to the Contest per Entrant. ALL OTHER FEDERAL, STATE AND LOCAL TAXES ASSOCIATED WITH THE RECEIPT OR USE OF ANY PRIZES ARE THE SOLE RESPONSIBILITY OF THE WINNER. All prizes will be awarded. Submit your wholly original artwork, which might include sketches, paintings, sculptures, 3D images, etc., which is based on Sponsor's "Diablo," Hearthstone," "Heroes of the Storm," "Overwatch," "StarCraft," and "Warcraft" interactive game products (collectively, the "Blizzard Products") to: https://blizzard.qualtrics.com/jfe/form/SV_2h12g0Ow3O3RTwx. Each submission must be a high resolution JPEG file of no more than 5MB in size to be considered for the Contest. A submission must be your original work, and cannot include, in whole or part, any previously created work (i.e. a photoshop manipulation of an existing image would be disqualified).
- 6. Contest Rules. Sponsor shall choose the winners from all entrants who have submitted an entry prior to the Deadline. Winners shall be chosen by Sponsor at its sole discretion based upon which entrants display the most original, authentic and/or funny artistic expression that is based on the Blizzard Products. The decision of Sponsor is final. Prizewinners will be notified by e-mail at or before November 1, 2019. To claim a prize, winners should follow the instructions contained in their notification.
- 7. **Sponsor Use of Entries**. You hereby agree that in consideration of your being allowed the chance to enter the Contest, you hereby grant Blizzard Entertainment, Inc., a perpetual, non-exclusive, worldwide license and right to utilize the entry materials that you submit to Sponsor in connection with the Contest (collectively, "Entry Materials"). The Entry Materials will not be returned to any entrant. - 9. Collection of Information. The Entry Materials include a survey that requires you to enter your name, e-mail address, and country of residence. By entering the Contest, you consent to Sponsor's use of this information to inform you of open positions with Blizzard, and to associate your name with your submission in promotional materials for the Contest in the event that you are chosen to be a winner. As stated above, the Contest is not open to anyone under the age of majority in your country of citizenship. In the event that Sponsor becomes aware that you are under the age of majority in your country of citizenship Sponsor will delete, erase or destroy any and all personally identifiable information that is obtained from the Entry Materials.
