## **Official Rules**

## 2018 Heroes BlizzCon Twitch Drops

Please read these rules before participating in the 2018 Heroes BlizzCon Twitch Drops promotion (hereafter referred to as the "Promotion"), and by participating in the Promotion, you agree to be bound by these Official Rules and represent that you satisfy all of the eligibility requirements contained in Section 1 below.

- 1. Eligibility. NO PURCHASE NECESSARY TO ENTER OR WIN. **BLIZZARD** ENTERTAINMENT, INC. ("SPONSOR"), IS THE SPONSOR OF THIS PROMOTION. - **2. - **3. Promotion Period**. The Promotion shall commence on 9:00 AM PM PDT October 25, 2018 and shall continue in duration until November 3, 2018 at 7:00 PM PDT (the "Promotion Period"). All entries must be received by the end of the Promotion Period to be eligible to win a prize.
- **4. How to Enter**. Entrants will be eligible to participate in this Promotion (as detailed below) by following these steps:
  - (i) Create or log in to your Blizzard Battle.net account;
  - (ii) Link your Twitch account to your Battle.net account; and

(iii) view one of the Eligible Channels during the Eligible Broadcast Time for no less than one (1) hour to qualify for that day's random Drops.

## 5. Drops Earned through viewing Eligible Broadcasts.

- (i) **Loot Chest Prize.** Entrants who watch a cumulative total of four (4) hours of Eligible Broadcasts will earn one (1) Rare Loot Chest during the Promotion.
- (ii) **Cheery Vikings Portrait.** Entrants who watch a cumulative total of eight (8) hours of Eligible Broadcasts will earn one (1) Cheery Vikings Portrait during the Promotion.
- (iii) **Cheery Vikings Spray.** Entrants who watch a cumulative total of twelve (12) hours of Eligible Broadcasts will earn one (1) Cheery Vikings Spray during the Promotion.

## 6. Random Program drops.

(i) **Common Loot Chests**. Starting at 9:00 AM on October 25, 2018 PDT, and continuing until November 3, 2018 at 7:00 PM PDT (the "Random Program Drop Period"), all viewers who satisfy eligibility requirements for a particular hour, will be entered into a random prize draw for the chance to win one of the Five Hundred (500) common loot chests dropped during that hour. Drops will begin 1 hour after each broadcast begins, and occur every hour during the scheduled broadcast time, usually at the end of the hour, excluding the final hour of that day when the Drop will occur 30 minutes before the broadcast of the day is scheduled to conclude. Each random drop will contain one (1) common loot chest with an approximate retail value of \$1.00.

- **7. Random Heroic Account Unlocks**. Each day during the Promotion Period, three (3) Qualified Entrants will be chosen at random to receive a digital code that will unlock all available Hero characters in Heroes of the Storm. Entrants will need to view one of the Eligible Channels during the Eligible Broadcast Time for no less than one (1) hour to qualify for that day's random drop prizes
- 8. Notification and Verification of Gifts or Prizes. Within 48 hours of a participant being determined as a winner of a prize hereunder, the digital code that will unlock all available Hero characters in Heroes of the Storm will be credited to the Battle.net accounts of the persons chosen at random to receive them. A valid Heroes of the Storm game license is required to utilize the prize. - 11. Collection of Information. The Entry Materials include a survey that requires you to enter your name, e-mail address, and state of residence. By participating in this Promotion, you consent to Sponsor's use of this information to inform you of open positions with Blizzard (provided that Sponsor shall provide you with the opportunity to opt-out of such communications), and to associate your name with your submission in promotional materials for the Promotion in the event that you are chosen to be a winner. or state of residence without the written consent of their parent or guardian. In the event that Sponsor becomes aware that you are under the age of majority in your country of citizenship, and consent from your parent or guardian was not obtained, Sponsor will delete, erase or destroy any and all personally identifiable information that is obtained from the Entry Materials.
