## **OFFICIAL RULES**

## HEARTHSTONE® BATTLEGROUNDS DRAGONS UPDATE TWITCH DROPS

Please read these rules ("Official Rules") before participating in the Hearthstone® Battlegrounds Dragons Update Twitch Drops promotion (the "Promotion"). By participating in the Promotion, you agree to be bound by these Official Rules and represent that you satisfy all of the eligibility requirements contained in Section 1 below.

- 1. Eligibility. NO PURCHASE NECESSARY TO ENTER OR WIN. BLIZZARD ENTERTAINMENT, INC. ("SPONSOR"), IS THE SPONSOR OF THIS PROMOTION.   - (d) View a Twitch channel which is listed under the Hearthstone category and has Twitch drops enabled by the channel owner ("Eligible Channel(s)") during the Promotional Period while logged into your Twitch account.
- 5. **Drop Rewards.** All Entrants who satisfy the eligibility requirements and watch a cumulative total of three (3) hours of any Eligible Channel during the Promotional Period will earn one (1) digital *Hearthstone: Descent of Dragons*<sup>TM</sup> card pack with an approximate retail value of \$1.50 USD.
