THE BLIZZARD ENTERTAINMENT WEEKLY MUTATION CONTEST

- 1. Eligibility. BLIZZARD ENTERTAINMENT, INC., A DELAWARE CORPORATION (referred to herein as "SPONSOR") IS THE SPONSOR OF THIS CONTEST. THIS CONTEST IS OPEN ONLY TO RESIDENTS OF THE UNITED STATES, CANADA, MEXICO, AUSTRALIA, MALAYSIA, NEW ZEALAND, SINGAPORE, THAILAND, ARGENTINA, BRAZIL, CHILE, AUSTRIA, BELGIUM, BULGARIA, CROATIA, THE CZECH REPUBLIC, FINLAND, FRANCE, GERMANY, HUNGARY, IRELAND, ITALY, NORWAY, POLAND, PORTUGAL, RUSSIA, SERBIA, SLOVENIA, SPAIN, SWEDEN, SWITZERLAND, THE UKRAINE, THE UNITED KINGDOM, SOUTH KOREA, TAIWAN, AND THE PEOPLE'S REPUBLIC OF CHINA WHICH ARE: (I) THIRTEEN YEARS OF AGE OR OLDER ON THE DATE REFERENCED BELOW AS THE START DATE FOR THE CONTEST; (ii) HAVE AN ACTIVE LICENSE FOR STARCRAFT II ATTACHED TO THE ENTRANT'S BATTLE.NET ACCOUNT: AND (iii) WHO ARE NOT RESIDENTS OF THE STATES OF NORTH DAKOTA, CONNECTICUT, OR MARYLYAND IN THE UNITED STATES; THE PROVINCE OF QUEBEC, CANADA OR RESIDENTS OF THE AUSTRALIAN STATES OF VICTORIA, QUEENSLAND OR THE AUSTRALIAN CAPITAL TERRITORY ("ENTRANTS"). If you are under the legal age of majority in your country of residence, or your state of residence (a "Minor"), one of your parents or legal guardians must submit a signed, written statement that they have read, understood and agree to these Contest rules with your entry, and that such agreement constitutes acceptance of these Contest rules on behalf of you and themselves. If you reside in the States of North Dakota, Connecticut or Maryland in the United States, the Province of Quebec in Canada, or Queensland, Victoria or the Australian Capital Territory in Australia, you are not eligible to participate in this Contest. To be eligible to win a prize, entries must be completed and received by Sponsor in the format designated below. - 3. Contest Period. The Contest shall commence on 10:00 AM PST September 1, 2016 (the "Start Date"), and shall continue in duration until 11:59 PM PST on September 15, 2016 (the "Deadline"). All entries must be received by the Deadline to be eligible to win a prize.
- 4. How to Enter. To enter, a qualified entrant will create a post in Blizzard's 'Co-op Missions Discussion' forum (http://us.battle.net/forums/en/sc2/22295482) (or for non-English speakers, in the appropriate forum as designated by Sponsor) detailing their Mutation scenario. Each submission shall be subject to the following requirements:
 - a. The title of the entry post must begin with "[Mutation Creation]", followed by the name of the mutation. An example of this would be, "[Mutation Creation] Train of the Dead;"
 - b. The body of the entry post must contain a description of the Mutation, that includes:
 - i. Name(s) and description(s) of each mutator(s), (Must include 1 but no more than 3 mutators);
 - ii. Contestants can create their own or use existing mutators; and
 - iii. A description of each mutator must be included; and
 - iv. A brief description of how your Mutation will work during gameplay on one of these Co-op Missions:
 - Lock & Load

- 5. Judging. Following the Deadline, Sponsor shall review the submissions to confirm that the submissions meet the Contest requirements, and then select five (5) submissions that will be made available by Sponsor for judging by the StarCraft II community. The submissions that will be made available for public judging will be those submissions that, in Sponsor's sole opinion, are the most fun, engaging, and creative. Thereafter, between September 20, 2016 and September 27, 2016 (the "Voting Period"), all approved submissions will be made available for voting on Sponsor's StarCraft II gaming site (the "Site"), and visitors to the Site may vote a maximum of once during the Voting Period. Voters must have a Battle.net account to register a vote. The use of any automated launching or entry software or any other mechanical or electronic means that permits visitors to vote repeatedly is prohibited. The submissions that receives the most votes from the StarCraft II Community during the Voting Period shall be the winner of the Contest. Entrant acknowledges and agrees that the public votes are a factor in the winner selection process. Winners will be announced on or about or about September 28, 2016. The decision of Sponsor is final.
- 6. Prize. The Winner will have the Mutation that the Winner submitted for the Contest adapted into a future StarCraft II Weekly Mutation, understanding that Blizzard may edit or alter the Mutation for gameplay or performance concerns, and be credited in the game description of that week's Weekly Mutation. Such credit can be in the form of the Winner's full name, Battletag, or some combination, at the discretion of the Winner.
- 7. Sponsor Use of Entries. In consideration of your being allowed the chance to enter the Contest, you assign any and all right, title and interest in the Game that you submit to Sponsor ("Entry Materials"); you irrevocably waive all rights of "droit morale" or "moral rights" of authors or any similar rights or principles of law that You may now or later have in the Game (whether now existing or hereinafter enacted). You hereby warrant and represent that (a) you own all rights to all Entry Materials submitted by you; and (b) all such Entry Materials are original works of authorship on your part and have not been copied, in whole or in part, from any other work and do not violate, misappropriate or infringe any copyright, trademark or other proprietary right of any other person or entity.
- 9. Collection of Information. The Entry Materials include a survey that requires you to enter your name, e-mail address, and state of residence. By entering the Contest, you consent to Sponsor's use of this information to inform you of open positions with Sponsor, and to associate your name with your submission in promotional materials for the Contest in the event that you are chosen to be a winner. As stated above, the contest is not open to anyone under the age of majority in your country of citizenship. In the event that Sponsor becomes aware that you are under the age of majority in your country of citizenship Sponsor will delete, erase or destroy any and all personally identifiable information that is obtained from the Entry Materials. In the event that you are a citizen of France and/or any of the other countries whose citizens are eligible for this Contest, and pursuant to French law pertaining to data collection and processing, you are informed that the data collector is Blizzard Entertainment, Inc., and the data collected will be transferred to the United States of America. Entrants agree to be bound by these Official Rules and by the decisions of Sponsor, which are final and binding in all respects. Sponsor reserves the right to change these Official Rules at any time, in its sole discretion, and to suspend or cancel the Contest or any entrant's participation in the Contest should viruses, bugs, unauthorized human intervention or other causes beyond Sponsor's control affect the administration, security or proper play of the Contest or Sponsor otherwise becomes (as determined in its sole discretion) incapable of running the Contest as planned. Entrants who violate these Official Rules, tamper with the operation of the Contest or engage in any conduct that is detrimental or unfair to Sponsor, the Contest or any other entrant (in each case as determined in Sponsor's sole discretion) are subject to disqualification from entry into the Contest.
