## **Official Rules**

## Rock the Cabinet, "Play. Vote. Win." Contest

- Eligibility. BLIZZARD ENTERTAINMENT, INC., A 1. DELAWARE CORPORATION (referred to herein as "SPONSOR") IS THE SPONSOR OF THIS CONTEST. THIS CONTEST IS OPEN ONLY TO RESIDENTS OF THE UNITED STATES, CANADA, BELGIUM, BELARUS, BULGARIA, CROATIA, CZECH REPUBLIC, FRANCE, HUNGARY, IRELAND, ITALY, THE GRAND DUCHY OF LUXEMBOURG, NORWAY, POLAND, SERBIA, SPAIN, SWEDEN, SWITZERLAND, THE UNITED KINGDOM, AUSTRALIA, INDONESIA, MALAYSIA, NEW ZEALAND, THE PHILIPPINES, THE REPUBLIC OF KOREA, SINGAPORE, TAIWAN, THAILAND AND VIETNAM WHICH ARE: (i) THIRTEEN YEARS OF AGE OR OLDER ON THE DATE REFERENCED BELOW AS THE START DATE FOR THE CONTEST; (ii) WHO HAVE REGISTERED A BATTLE.NET ACCOUNT PRIOR TO THE COMMENCEMENT OF THE CONTEST THAT REMAINS IN GOOD STANDING THROUGHOUT THE CONTEST PERIOD; AND (iii) WHO ARE NOT RESIDENTS OF THE STATES OF NORTH DAKOTA, VERMONT, CONNECTICUT, OR MARYLYAND IN THE UNITED STATES; THE PROVINCE OF QUEBEC, CANADA OR RESIDENTS OF THE AUSTRALIAN STATES OF VICTORIA, QUEENSLAND OR THE AUSTRALIAN CAPITAL TERRITORY ("ENTRANTS"). - **3. Contest Period.** The Contest shall commence on 10:00 AM PST January 8, 2016 (the "Start Date"), and shall continue in duration until 11:59 PM PST January 15, 2016 (the "Deadline"). All entries must be received by the Deadline to be eligible to win a prize.
- **4. Contest Description**. The entry requirements for the Grand Prize and Runner Up Prizes differ as follows:
  - A. Runner Up Prize. By entering the Contest, Blizzard will access your your name, e-mail address, and state of residence from your Battle.net account, and you consent to Sponsor's use of this information to associate your name with your submission in promotional materials for the Contest in the event that you are chosen to be a winner. As stated above, the contest is not open to anyone under the age of majority in your country of citizenship. In the event that Sponsor becomes aware that you are under the age of majority in your country of citizenship Sponsor will delete, erase or destroy any and all personally identifiable information that is obtained from the Entry Materials.
