## **OFFICIAL RULES**

## TOTALBISCUIT ANNOUNCER CONTEST

- Eligibility, BLIZZARD ENTERTAINMENT, INC., A DELAWARE CORPORATION 1. (REFERRED TO HEREIN AS "SPONSOR") IS THE SPONSOR OF THIS CONTEST. THIS CONTEST IS OPEN ONLY TO RESIDENTS OF THE AUSTRALIA, AUSTRIA, BELARUS, BELGIUM, BULGARIA, CANADA, CROATIA, DENMARK, ESTONIA, FINLAND, FRANCE, GERMANY, GREECE, HUNGARY, INDONESIA, IRELAND, ISRAEL, ITALY, KAZAKHSTAN, LATVIA, LITHUANIA, LUXEMBOURG, MALAYSIA, NEW ZEALAND, NORWAY, PHILIPPINES, POLAND, PORTUGAL, ROMANIA, RUSSIA, SAUDI ARABIA, SERBIA, SINGAPORE, SLOVAKIA, SLOVENIA, SOUTH AFRICA, SOUTH KOREA, SPAIN, SWEDEN, SWITZERLAND, TAIWAN, THAILAND, THE CZECH REPUBLIC, THE NETHERLANDS, THE PEOPLE'S REPUBLIC OF CHINA, THE UKRAINE, TURKEY, UNITED ARAB EMIRATES, UNITED KINGDOM, UNITED STATES, AND VIETNAM WHICH ARE: (i) OVER THE AGE OF MAJORITY IN THEIR COUNTRY OF RESIDENCE ON THE DATE REFERENCED BELOW AS THE START DATE FOR THE CONTEST; AND (ii) WHO ARE NOT RESIDENTS OF THE STATES OF NORTH DAKOTA, VERMONT, CONNECTICUT, OR MARYLAND IN THE UNITED STATES; OR THE PROVINCE OF QUEBEC, CANADA; AND (II) WHO ARE THIRTEEN (13) YEARS OF AGE OR OLDER AS OF DECEMBER 19, 2016; AND (C) WHO ARE NOT RESIDENTS OF THE STATES OF ARIZONA, NORTH DAKOTA, VERMONT, CONNECTICUT, OR MARYLAND IN THE UNITED STATES; OR THE PROVINCE OF QUEBEC, CANADA ("ENTRANTS"). If you are between the age of thirteen (13) years of age and the legal age of majority in your jurisdiction of residence, or your state of residence (a "Minor"), one of your parents or legal guardians must submit a signed, written statement that they have read, understood and agree to these rules with your entry, and that such agreement constitutes acceptance of these rules on behalf of you and themselves. If you reside in the States of Arizona, North Dakota, Vermont, Connecticut or Maryland in the United States, or the Province of Quebec in Canada, you are not eligible to participate in this Contest. To be eligible to win a prize, entries must be completed and received by Sponsor in the format designated below. - 2. **Disclaimer.** Sponsor, all participating sponsors and any of their respective parent companies, subsidiaries, affiliates, directors, officers, professional advisors, employees and agencies will not be responsible for: (a) any late, lost, misrouted, garbled or distorted or damaged transmissions or entries; (b) telephone, electronic, hardware, software, network, Internet, or other computer- or communications related malfunctions or failures; (c) any Contest disruptions,

injuries, losses or damages caused by events beyond the control of Sponsor; or (d) any printing or typographical errors in any materials associated with the Contest. Sponsor is not responsible for any incorrect or inaccurate information, whether caused by any other users, by any other technical or human error which may occur in the processing of registrations or entries into the Contest, or otherwise in connection with the Contest, including without limitation any technical limitation that results in the disqualification or loss of ranking status of any Entrant into the Contest.

- **3.** Contest Period. The Contest shall commence on 10:00 AM PST January 19, 2017 (the "Start Date"), and shall continue in duration until 11:59 PM PST on January 26, 2017 (the "Deadline"). All entries must be received by the Deadline to be eligible to win a prize.
- **4. How to Enter**. To enter, a qualified entrant will record an impression of John Bain (alias TotalBiscuit) and upload it to a public hosting site such as Youtube. The qualified entrant will then email a link to this upload to <a href="mailto:SC2communityteam@blizzard.com">SC2communityteam@blizzard.com</a> with the subject line, "TB Contest" prior to the deadline.
- 5. Judging. Following the Deadline, Sponsor shall review the submissions to confirm that the submissions meet the Contest requirements, and then select five (5) submissions that, in Sponsor's sole opinion, are the most entertaining and accurate, as the winners of the Contest. Winners will be announced on or about January 31, 2017. The decision of Sponsor is final. Prizewinners will be notified by e-mail within fourteen (14) days thereafter. To claim a prize, winners should follow the instructions contained in their notification.

You hereby agree that in consideration of your being allowed the chance to enter the Contest, you hereby grant Blizzard Entertainment, Inc., a perpetual, non-exclusive, worldwide license and right to utilize the entry materials that you submit to Sponsor in connection with the Contest (collectively, "Entry Materials"). The Entry Materials will not be returned to any entrant. Without limiting the generality of the foregoing, you acknowledge that Sponsor shall have the right to use, modify, reproduce, publish, perform, display, distribute, make derivative works of and otherwise commercially and noncommercially exploit the Entry Materials in perpetuity and throughout the universe, in any manner or medium now existing or hereafter developed, without separate compensation to you or any other person or entity. You agree to take,

at Sponsor's expense, any further action (including, without limitation, execution of affidavits and other documents) reasonably requested by Sponsor to effect, perfect or confirm Sponsor's rights as set forth above in this paragraph 5.

- 8. Collection of Information. The Entry Materials include a survey that requires you to enter your name, e-mail address, and state of residence. By entering the Contest, you consent to Sponsor's use of this information to inform you of open positions with Blizzard, and to associate your name with your submission in promotional materials for the Contest in the event that you are chosen to be a winner. As stated above, the contest is not open to anyone under the age of majority in your country of citizenship. In the event that Sponsor becomes aware that you are under the age of majority in your country of citizenship Sponsor will delete, erase or destroy any and all personally identifiable information that is obtained from the Entry Materials.
