## **OFFICIAL RULES**

## **CO-OP COMRADES SWEEPSTAKES**

- Eligibility. BLIZZARD ENTERTAINMENT, INC., A DELAWARE CORPORATION 1. (REFERRED TO HEREIN AS "SPONSOR") IS THE SPONSOR OF THIS SWEEPSTAKES. THIS SWEEPSTAKES IS OPEN ONLY TO RESIDENTS THE UNITED STATES, ARGENTINA, AUSTRIA, BELARUS, BELGIUM, BELIZE, BOLIVIA, BULGARIA, CHILE, CANADA, CROATIA, DENMARK, ECUADOR, EL SALVADOR, ESTONIA, FRANCE, FINLAND, GERMANY, GREECE, GUATEMALA, HONDURAS, HONG KONG, HUNGARY, ICELAND, IRELAND, ISRAEL, ITALY, JAMAICA, JAPAN, LATVIA, LITHUANIA, LUXEMBOURG, MACAU, MEXICO, NICARAUGA, NORWAY, PERU, POLAND, PORTUGAL, PUERTO RICO, ROMANIA, RUSSIA, SERBIA, SLOVAKIA, SLOVENIA, SOUTH AFRICA, SOUTH KOREA, SPAIN, SWEDEN, SWITZERLAND, TAIWAN, THAILAND, THE CZECH REPUBLIC, THE NETHERLANDS, THE PEOPLE'S REPUBLIC OF CHINA, THE UKRAINE, THE UNITED KINGDOM, TURKEYAND VENEZUELA WHICH ARE: (i) OVER THE AGE OF MAJORITY IN THEIR COUNTRY OF RESIDENCE ON THE DATE REFERENCED BELOW AS THE START DATE FOR THE CONTEST; AND (ii) WHO ARE NOT RESIDENTS OF THE STATES OF NORTH DAKOTA, VERMONT, CONNECTICUT, OR MARYLAND IN THE UNITED STATES; OR THE PROVINCE OF QUEBEC, CANADA; AND (II) WHO ARE THIRTEEN (13) YEARS OF AGE OR OLDER AS OF DECEMBER 19, 2016; AND (C) WHO ARE NOT RESIDENTS OF THE STATES OF ARIZONA, NORTH DAKOTA, VERMONT, CONNECTICUT, OR MARYLAND IN THE UNITED STATES; OR THE PROVINCE OF QUEBEC, CANADA ("ENTRANTS"). The submission email shall also include the qualified entrants email address that is associated with the qualified entrant's Battle.net account.
- **4. Prizes.** Within ninty (90) days after the Deadline, Sponsor shall randomly select five (5) qualified entrants to receive a Stukov Commander code for StarCraft II, for both the qualified entrant and one (1) Co op partner of their choosing, with each Stukov Commander code having an approximate retail value of \$4.99 USD
