

## Official Rules

### Diablo III Boon of the Horadrim Sweepstakes

**1. Eligibility.** BLIZZARD ENTERTAINMENT, INC., A DELAWARE CORPORATION (referred to herein as "SPONSOR") IS THE SPONSOR OF THE DIABLO III BOON OF THE HORADRIM SWEEPSTAKES ("SWEEPSTAKES"). THIS SWEEPSTAKES IS OPEN ONLY TO RESIDENTS OF THE UNITED STATES, CANADA (EXCLUDING QUEBEC), AUSTRIA, BELARUS, BELGIUM, BULGARIA, CROATIA, CZECH REPUBLIC, DENMARK, EGYPT, ESTONIA, FINLAND, FRANCE, GERMANY, HUNGARY, ICELAND, ISRAEL, ITALY, KAZAKHSTAN, LATVIA, LITHUNIA, LUXEMBOURG, MALTA, NORWAY, POLAND, ROMANIA, SERBIA, SLOVAKIA, SLOVENIA, SOUTH AFRICA, STATE OF QATAR, SWITZERLAND, TUNISIA, TURKEY, THE UNITED KINGDOM, UKRAINE, HONG KONG, SOUTH KOREA, MACAU, TAIWAN AND THAILAND; WHICH ARE: (i) OVER THE AGE OF MAJORITY IN THEIR COUNTRY OF RESIDENCE ON THE DATE REFERENCED BELOW AS THE START DATE FOR THE SWEEPSTAKES; (ii) WHO HAVE AN ACTIVE TWITTER ACCOUNT; AND (iii) WHO ARE NOT RESIDENTS OF THE STATES OF NORTH DAKOTA, VERMONT, CONNECTICUT, OR MARYLAND IN THE UNITED STATES, OR THE PROVINCE OF QUEBEC, CANADA ("ENTRANTS"). B. Entering the Customized Xbox One Diablo III Console Giveaway. To enter for a chance to win a custom Diablo III skinned Xbox One console, qualified entrants must retweet the tweet focused on the Xbox One X Diablo III Console Giveaway provided by Blizzard at <https://twitter.com/Diablo> after the Start Date and prior to the Deadline.

**5. Prize.**

A. Customized PS4 Diablo III Console Giveaway Winner. After the Deadline, Blizzard shall randomly select one (1) qualified entrant as the winner of a PS4 Diablo III Console, with an approximate retail value of \$2,000.00 USD.
