

## DIABLO III ETERNAL COLLECTION QUEST FOR TREASURE CONTEST RULES

- 1. Eligibility.** BLIZZARD ENTERTAINMENT, INC., A DELAWARE CORPORATION, AND GAMESTOP, INC. (“SPONSOR”) ARE THE SPONSORS OF THE DIABLO III ETERNAL COLLECTION QUEST FOR TREASURE CONTEST (“CONTEST”). ELIGIBILITY FOR THIS CONTEST IS LIMITED TO RESIDENTS OF THE UNITED STATES, CANADA, AND MEXICO: (I) WHO ARE OVER THE AGE OF MAJORITY IN THEIR COUNTRY OF RESIDENCE, (II) WHO ARE NOT RESIDENTS OF THE STATES OF NORTH DAKOTA, VERMONT, CONNECTICUT, OR MARYLAND IN THE UNITED STATES, OR THE PROVINCE OF QUEBEC, CANADA, AND (III) HAVE A VALID BATTLE.NET ACCOUNT AND TWITCH ACCOUNT IN GOOD STANDING (“ENTRANTS”). Contest Period.** The Contest shall commence at 9:00 a.m., Pacific Daylight Time (PDT) on October 15, 2018 (the “Start Date”) and shall continue in duration until 9:00 AM Pacific Standard Time (PST) November 9, 2018 (the “Deadline”). All entries must be received by the Deadline to be eligible to win a prize.
- 4. How to Enter.** On October 15, 2018 at 9:00 a.m., Sponsor shall post a total of twelve (12) unique URLs (“Codes”). These Codes shall be either: (i) displayed at a physical location; or (ii) posted online. To enter the Contest, an Entrant must locate the Codes and redeem them for Contest entries at the following website: [d3loot.com](http://d3loot.com). Each Code shall be classified as either (1) common, (2) magic, (3) rare, or (4) legendary. Common Codes can be redeemed for one (1) entry into the Contest; magic Codes can be redeemed for two (2) entries into the Contest; rare Codes can be redeemed for three (3) entries into the Contest; and legendary Codes can be redeemed for four (4) entries into the Contest. Each Code can only be redeemed once per Entrant.

Prize Winners will be notified within ten (10) days of the Deadline, and must execute an affidavit of eligibility and furnish the necessary tax documentation before they can receive their Prize. Sponsor shall have the right to use, modify, reproduce, publish, perform, display, distribute, make derivative works of and otherwise commercially and non-commercially exploit your submitted joke, Instagram handle, name, character, likeness, and a biography of you in perpetuity and throughout the universe, in any manner or medium now existing or hereafter developed, without separate compensation to you or any other person or entity.
