Diablo III Season of Greed Sweepstakes

- 1. Eligibility. BLIZZARD ENTERTAINMENT, INC., A DELAWARE CORPORATION (referred to herein as "SPONSOR") IS THE SPONSOR OF THE DIABLO III SEASON OF GREED SWEEPSTAKES ("SWEEPSTAKES").
